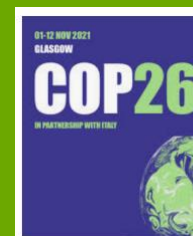

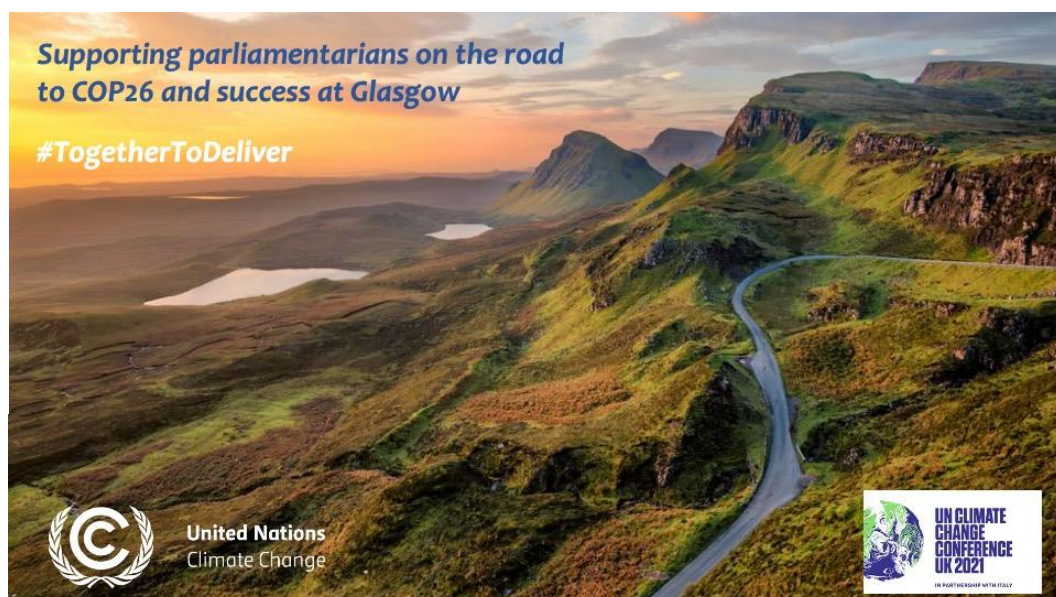

Updates from the UNFCCC and COP26 Presidency

Access to COP 26 – latest news

Access to COP26 for delegates and observers alike has been a hot button issue. Here is an overview of recent updates from the UK Presidency:

UK COP26 COVID-19 Updates: On 1 September 2021, the UK Presidency provided the following update for delegates:- [Delegates - UN Climate Change Conference \(COP26\) at the SEC – Glasgow 2021 \(ukcop26.org\)](#) As suspected, numbers are significantly down from COP25 in Madrid, with the COP26 Blue Zone (restricted to delegates) designed to hold a maximum capacity of 10,000 delegations at any one time.

Parliaments as critical arms of government have key roles to play in ensuring that the drive to Net Zero emissions by every sector integrates a just transition approach to ensure No One is Left Behind as urged by Agenda 2030.

Parliaments in the News

Monday, September 13, 2021, "The Housing, Communities and Local Government Committee [of the British House of Commons] are looking at what local councils can do to achieve Net Zero carbon emissions."

On September 22, 2021, there will be a high-level UK-Nigeria Parliamentary Workshop to discuss possible ways Nigerian legislators can help engender just transition to net zero and get the government to scale up on its ambitions.

The Agriculture Committee of the European Union (EU) Parliament on Thursday September 9, 2021 approved a deal that will overhaul the region's farming subsidies and help cut down on the 10% of EU emissions that come from agricultural produce. GLOBE Legislators Summit

During the COP26 events, GLOBE International shall be hosting a cross-party Legislators' Summit at the Scottish Parliament Edinburgh on November 5-6, 2021. The Summit which will have 150 participants physically present is expected to have an additional 5,000 participants join virtually. “The Moment”

Ahead of COP26, GLOBE will be working with partners to promote dialogue between young people and parliamentarians on how to solve the climate crisis. These will take the form of Student-MP Climate Surgeries in London, and across Scotland with MSPs and MPs, on Friday 29 October. It is intended as a means of improving political understanding and supporting informed engagement on a critical issue for young people. The dialogues, billed as "The Moment", will take place across Scotland with the support of Scotland's Children and Youth Parliaments.
