## **Baku Climate Action Week**

# Roundtable on Strengthening Climate Laws and Institutions for Climate Resilience and Net Zero Transition

Date: Monday, 29 September 2025

#### Description

This session will focus on the role of climate laws and institutions – for example, independent climate change advisory councils – in shaping the next generation of Nationally Determined Contributions (NDCs) and in creating carbon markets to drive transition in the real economy.

Experts will discuss best practices drawn from existing climate legislative frameworks and policies across different countries to ensure a sustainable and fair "net zero" transition by 2050.

During the roundtable, the Azerbaijani version of GLOBE's "Parliamentary Guide on Article 6 and Carbon Markets" will be presented. This launch coincides with preparations for the Article 6 Ambition Dialogue to be held under UNFCCC COP30 in Belém and highlights the growing role of the private sector in implementing national climate plans and NDCs.

#### Introduction

Parliaments worldwide have played a central role in shaping the global architecture of climate legislation and have become a driving force in raising ambition for climate action.

Since the Kyoto Climate Summit (COP3) in 1997, the number of climate laws and policies has increased from 100% from around 50 to over 5,000 globally. Today, net-zero commitments cover



92% of the global economy, with more and more countries enshrining these goals into law. Several states have also adopted comprehensive climate framework laws to guide national ambition.

The current trajectory shows that global average temperatures may rise between 2.4°C and 2.9°C by 2100, and up to 3.1°C–3.7°C if climate policies are not strengthened. Achieving the Paris Agreement goal of limiting warming to 1.5°C is nearly impossible under current trends. To reach this target, climate policies must be significantly reinforced, and emissions reductions must go beyond existing commitments.

Therefore, the role of parliaments—in enacting laws, approving budgets, overseeing government action, and building public consensus—is vital.

This session will present the latest updates on parliamentary engagement in the climate agenda. The aim is to bridge the "Ambition Gap" between the scientific findings revealed by the first Global Stocktake under the Paris Agreement in 2023 and the current trajectory of global greenhouse gas emissions.

As the private sector's decisive role in achieving climate targets is now widely acknowledged, and with the UNFCCC's Article 6 Ambition Dialogue scheduled for COP30 in Belém, **the Azerbaijani edition of the Parliamentary Guide on Article 6 and Carbon Markets will be launched.** This publication was first unveiled on 25 August 2025 at the Pre-COP30 Parliamentary Forum during Rio Climate Action Week in Rio de Janeiro, Brazil.
